Test circumstances Compliance has been checked according to Directive 82/711/EEC , 85/572/EEC and belgian food contact legislation .
The kitchen utensils are intended to be used with different kind of foods.
According to EU guidelines the products were tested on worst expected conditions at normal use. This included testing in 0.5% citric acid up to 2 hours 100°C (in case of hot food contact). The Scissors were tested in tap water at 40°C for 0.5 hour.
The surface to volume ratio was 6 dm²/liter. After this tests the specific migration limits of metals named in the Council of Europe regulations and Dutch national food contact regulations were below the limits. Total migration was below 10 mg/dm² as specified in EU 1935/2004/EC.
