 The surface to volume ratio was 6 dm²/liter. In all cases the total migration was below the limit of 10 mg/dm² or 60mg/kg food. The specific migration of metals was below the limits of Council of Europe regulations and Dutch food contact legislation.
 In case of other uses than normal domestic use indicated above, compliance has to be checked by user.
